**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID
EVALUATION REPORT AND DECLARING THE SINGLE CALCULATED BID
(SCB) AND RECOMMENDING FURTHER FOR POST QUALIFICATION**

BAC Resolution No. 030-A Series of 2021

WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Supply, Delivery and Installation of Information Communication Technology (ICT) Equipment for the Upgrading of Instructional Laboratories at BPSU Main Campus (PR No. MC2021-08-0191)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, *three (3)* prospective bidders, namely: (1) *PC City Computer Shop*, (2) *Handlink, Inc.*, and (3) *Avtech Information Technology Solutions, Inc.* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference on October 04, 2021;

WHEREAS, only two (2) bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals prior to the deadline. Only *PC City Computer Shop* passed the preliminary examinations when the bid proposals were evaluated;

WHEREAS, *Handlink, Inc.* was disqualified for Lot 1 due to lack of manpower schedule, which is primarily included in the checklist. In this regard, its financial bid for Lot 1 was not read but was qualified to proceed only for Lot 2, 3 and 4. After opening the financial envelopes, *Handlink, Inc.* was also declared disqualified due to violation of Section 31 of R.A.9184 and its IRR, which states that bid prices exceeding the approved budget for the contract shall be automatically disqualified;

- To recommend further that the TWG will conduct the Post- qualification on the bidder with Single Calculated Bid (SCB) – **PC CITY COMPUTER SHOP** and the bidder with SCB to prepare additional post qualification document pursuant to Section 34.2 on the 2016 Revised Implementing Rules and Regulation of the RA 9184.

BAC RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID
BAC Resolution No. 030-C Series of 2021

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the project *Supply, Delivery and Installation of Information Communication Technology (ICT) Equipment for the Upgrading of Instructional Laboratories at BPSU Main Campus (PR No. MC2021-08-0191)* posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days;

WHEREAS, in response to the said advertisement, *three (3)* prospective bidders, namely: (1) *PC City Computer Shop*, (2) *Handlink, Inc.*, and (3) *Avtech Information Technology Solutions, Inc.* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference on October 04, 2021. Two (2) bidders, namely: (1) *Handlink, Inc.* and (2) *PC City Computer Shop*, purchased the bidding documents and submitted their bid proposals prior to the deadline. Only *PC City Computer Shop* passed the preliminary examinations when the bid proposals were evaluated on October 25, 2021;

WHEREAS, *Handlink, Inc.* was disqualified for Lot 1 due to lack of manpower schedule. In this regard, its financial bid for Lot 1 was not read, but was qualified to proceed only for Lot 2, 3 and 4. After opening the financial envelopes, *Handlink, Inc.* was also declared disqualified due to violation of Section 31 of R.A.9184 and its IRR, which states that bid prices exceeding the approved budget for the contract shall be disqualified outright. The **Technical Working Group, End-User Unit** and the BAC post-qualified and declared the bid of **PC CITY COMPUTER SHOP** with the single calculated and responsive bid for Lot 1 only;

WHEREAS, the bid of **PC CITY COMPUTER SHOP** was found to be substantially complying;

WHEREAS, the above procurement project is composed of four (4) lots, partial bids were allowed per lot. However, only Lot 1 had responsive bid. Lot 2, 3 and 4 were declared failure of bidding due to the disqualification of *Handlink, Inc.* The said failed project shall be subject to another procurement process.
