WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the Project *Supply, Delivery and Installation of Computer Laboratory Equipment, Network Peripherals and Software for Old Engineering Building at BPSU Abucay Campus (PR No. AC2021-03-361)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the advertisement, two (2) suppliers/bidders signified its intention to participate by submitting their letter of intent but only one of them purchased the bidding documents;

WHEREAS, the lone (1) bidder submitted its bidding documents on April 19, 2021 and the scheduled bid opening is April 20, 2021 at 9AM. The sole bidder passed the preliminary examinations when the bid proposal was evaluated;

WHEREAS, the lone bidder, PC City Computer Shop submitted their partial bid, for Lot 1 only;

WHEREAS, the **Technical Working Group (TWG)** declared the Bid of **PC CITY COMPUTER SHOP** as the single calculated bid for lot 1 only;

BAC Resolution No. 007-C Series of 2021

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the Project *Supply, Delivery and Installation of Computer Laboratory Equipment, Network Peripherals and Software for Old Engineering Building at BPSU Abucay Campus (PR No. AC2021-03-361)* posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days.

WHEREAS, in response to the said advertisement **two (2)** prospective suppliers namely (1) *Masangkay Computer Center*, and (2) *PC City Computer Shop* their intention to participate by submitting their letter of intent, but only PC City Computer Shop purchased the bidding documents. PC City Computer Shop, the lone bidder submitted its bidding documents last April 19, 2021, the bid submitted was partial bid or for Lot 1 only and passed the preliminary examinations when the technical documents were evaluated on the following day, the scheduled bid opening. The **Technical Working Group/ End-User Unit** post-qualified and declared the Bid of **PC CITY COMPUTER SHOP**, with the single calculated responsive bid for Lot 1 only.

WHEREAS, the bid of **PC CITY COMPUTER SHOP** for **Lot 1** was found to be substantially complying.

WHEREAS, the procurement project is composed of two (2) lots, partial bids were allowed, however, only Lot 1 had responsive bid. No bids were received for Lot 2, therefore it will be subjected to another procurement process.
