**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID

**BAC Resolution No. 027-A Series of 2021**

**WHEREAS**, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the Project *Construction of Perimeter Fence at BPSU Abucay Campus (PR No. AC2021-07-470)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

**WHEREAS**, in response to the said advertisement, four (4) prospective bidders signified their intention to participate by submitting their letter of intent. Two (2) of them namely: (1) *PCMJ Enterprise* and (2) *Lhenicsson Builders Corporation* attended the Prebid Conference on September 16, 2021 via the *Google Meet* video conferencing, but failed to purchase the bidding documents. Two (2) other bidders have successfully purchased and submitted the bidding documents on time namely: (1) *S.M. Severino Construction & Trading* and (2) *Victoria Builders and Trading*;

**WHEREAS**, when the bid proposals on technical component were evaluated, S.M. Severino Construction and Trading passed and qualified, while Victoria Builders and Trading failed and was disqualified due to failure in meeting the SLCC requirement, which must be similar to the abovementioned project;


**WHEREAS**, the preliminary detailed evaluation of proposal was conducted on the date of opening of bids, which was held on September 28, 2021;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:




**BAC Resolution No. 027-C Series of 2021**

**WHEREAS**, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the Project *Construction of Perimeter Fence at BPSU Abucay Campus (PR No. AC2021-07-470)*; posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days.

**WHEREAS**, in response to the said advertisement, four (4) prospective bidders signified their intention to participate by submitting their letter of intent. Two (2) of them namely: (1) PCMJ Enterprise and (2) Lhenicsson Builders Corporation attended the Prebid Conference on September 16, 2021 via the Google Meet video conferencing, but failed to purchase the bidding documents. Two (2) other bidders have successfully purchased and submitted the bidding documents on time namely: (1) S.M. Severino Construction & Trading and (2) Victoria Builders and Trading. S.M. Severino Construction and Trading passed the preliminary examination when the bid proposals on technical component were evaluated, while Victoria Builders was disqualified due to failure in meeting the SLCC requirement, which must be similar to the abovementioned procurement. The **Technical Working Group/ End-User Unit** post-qualified and declared the Bid of **S.M. SEVERINO CONSTRUCTION AND TRADING**, with the single calculated and responsive bid.
