WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the *Procurement of Student Group Accident Insurance for AY 2021-2022 at BPSU Central Office (PR No. CO2021-09-0322)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, *three (3) prospective bidders*, namely: (1) *Fortune General Insurance Corporation*, (2) *Royal Care Marketing Services, Inc. (COCOLIFE)*, and (3) *Standard Insurance Co., Inc* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference on September 20, 2021;

WHEREAS, only two (2) bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals prior to the deadline. Both bidders passed the preliminary examinations when the bid proposals were evaluated;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

Both bidders passed the preliminary examinations when the bid proposals were evaluated on bid opening on October 4, 2021. The **Technical Working Group, End-User Unit** and the BAC post-qualified both bidders with similar bid price and declared the bid of **STANDARD INSURANCE CO., INC.**, with the lowest calculated and responsive bid.
