WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the Project *Supply, Delivery Installation, Testing and Commissioning of Solar Panel System at BPSU Dinalupihan Campus (PR No. DC2021-07-061)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG POST
QUALIFICATION EVALUATION REPORT AND DECLARING LCRB**

BAC Resolution No. 025-B Series of 2021

WHEREAS, the Bataan Peninsula State University- Bids and Awards Committee confirmed the TWG Bid Evaluation Report and declare the Lowest Calculated Bid- **SOLARSET CORPORATION**;

WHEREAS, on September 1, 2021, the day following the bid opening, the both the TWG and End-User Unit conducted the Post Qualification of the Lowest Calculated Bid in order to determine whether the bidder complies with and is responsive to all the requirement and conditions as specified in the Bidding Documents.

WHEREAS, in September 10, 2021, the End-User Unit made a recommendation letter to post disqualify SOLARSET CORPORATION for failing to comply with the ff. requirements: (1) On-site visit was not conducted, (2) System architecture and panel layout and drawings were not presented to Dinalupihan Campus, and (3) Proof of certification and accreditation as system integrator of Panasonic Manufacturing Philippines Corporation was not submitted. Thus, the BAC followed the recommendation of the TWG and declared it post-disqualified on September 13, 2021;

WHEREAS, in September 15, 2021, **SOLARSET CORPORATION** filed a Motion for Reconsideration (MR), which was immediately enacted by the BAC. The BAC and TWG again reviewed the post-qualification process, comparing the technical specifications or requirements by the end-user unit and the ones submitted by the bidder, if these were complied. The BAC and TWG verified, validated and ascertained all statements made and documents submitted by the bidder with the Lowest Calculated Bid (LCB), using non-discretionary criteria, the Technical requirements, and Financial requirements; The findings of the BAC and TWG was discussed in details in BAC RESOLUTION No. 023 Series of 2021 declaring **SOLARSET CORPORATION** to have the **Lowest Calculated and Responsive Bid**.
