BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID EVALUATION REPORT AND DECLARING THE SINGLE CALCULATED BID (SCB) AND RECOMMENDING FURTHER FOR POST QUALIFICATION

WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Improvement of Façade of Business Center and ICT Building at BPSU Dinalupihan Campus (PR No. DC2022-03-025)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, two (2) prospective bidders, namely: (1) D.M. Madarang Construction and (2) M.J. Camacho Construction, signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference, which was held on March 31, 2022;

WHEREAS, both abovementioned bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals prior to the deadline on April 12, 2022. When the bid proposals were evaluated, *M.J. Camacho Construction* was disqualified from the bidding due to improper statement of the method of construction in the duly signed construction methods, failure to attach valid PRC license ID of the Civil Engineer, failure to attach Red Cross Certification of First Aider, failure to include in the list of required equipment the concrete vibrator and dump truck, and non-conformity with DOLE format of Construction Safety and Health Program, which must be duly signed by a professional safety officer;

MADARANG CONSTRUCTION as the Single Calculated Bid (SCB) as Read;
