WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Supply and Delivery of Adult Patient Simulator High Fidelity Mannequin for Virtual Hospital and Instruction of College of Nursing and Midwifery (CNM) at BPSU Main Campus (PR No. MC2021-12-0266)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, *two (2)* prospective bidders, namely: (1) *Aspen Multi-System Corporation* and (2) *SciGate Technology Corporation*, signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference on December 28, 2021;

WHEREAS, both abovementioned bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals prior to the deadline. The two bidders passed the preliminary examinations when the bid proposals were evaluated;

**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG POST
QUALIFICATION EVALUATION REPORT AND DECLARING LCRB**

BAC Resolution No. 11-B Series of 2022

WHEREAS, the Bataan Peninsula State University- Bids and Awards Committee confirmed the TWG Bid Evaluation Report and declared the ***Lowest Calculated Bid (LCB)– SCIGATE TECHNOLOGY CORPORATION***;

WHEREAS, on January 11, 2022, the TWG conducted an in-depth Post Qualification of the ***LCB*** in order to determine whether the bidder complies with and is responsive to all the requirement and conditions as specified in the Bidding Documents;

WHEREAS, the TWG verified, validated and ascertained on January 13, 2022 that all statements made and documents submitted by the bidder, using non-discretionary criteria, the Technical requirements, and Financial requirements are lacking of the required features vital for the department’s endeavor to provide high quality teaching-learning experience to nursing and midwifery students;

WHEREAS, *SciGate Technology Corporation* was requested to confirm the said lacking features. On January 20, 2022, *SciGate Technology Corporation* responded to the said request indicating in their response letter their compliance on the additional features mentioned by the end-user unit;

WHEREAS, due to the incessant disagreement on the said lacking features between the ***LCB*** and the end-user unit, the BAC decided to conduct a face-to-face meeting for the finalization of the Post Qualification Evaluation Report of the said project on February 14, 2022. As a result of the discussion, *SciGate Technology Corporation* admitted to their lacking features and acknowledged the post-disqualification findings;

WHEREAS, on February 18, 2022, the TWG conducted the Post Qualification of the ***2nd LCB, ASPEN MULTI-SYSTEM CORPORATION*** to determine whether the said bidder complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The TWG verified, validated and ascertained all statements made and documents submitted by the bidder, using non-discretionary criteria, the Technical requirements, and Financial requirements;

WHEREAS, upon presentation of the TWG Report on the Post Qualification Evaluation to the BAC, the TWG properly discussed and deliberated the contents of the Report;

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the project *Supply and Delivery of Adult Patient Simulator High Fidelity Mannequin for Virtual Hospital and Instruction of College of Nursing and Midwifery (CNM) at BPSU Main Campus (PR No. MC2021-12-0266)* posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days;

WHEREAS, both bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals prior to the deadline. The two bidders passed the preliminary examinations when the bid proposals were evaluated on January 10, 2022;

WHEREAS, the **Technical Working Group, End-User Unit** and the **BAC** post-qualified and declared the bid of **SCIGATE TECHNOLOGY CORPORATION** with the *Lowest Calculated Bid (LCB)*. However, the said bidder was declared **POST-DISQUALIFIED** due to its lacking on the additional features specified on the bid bulletin, which *SciGate Technology Corporation* admitted and acknowledged during the face-to-face meeting for the finalization of Post Qualification Evaluation Report conducted on February 14, 2022;

WHEREAS, the TWG post-qualified the *2nd LCB* on February 21, 2022 and found the bid of **ASPEN MULTI-SYSTEM CORPORATION** to be substantially complying;
