CONTRACT AGREEMENT

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation, conditions of the contract, herein attached as Annex "A";

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *One million One Hundred Thirty Three Thousand Two Hundred Seventy Five Pesos Only (Php 1,133,275.00)* or such other sum as may be ascertained, STANDARD INSURANCE CO., INC. agrees to PROCUREMENT OF STUDENT ACCIDENT INSURANCE FOR AY 2023-2024 FOR BPSU STUDENTS with PR No. MCO2023-10-892 in accordance with his/her/its Bid.
- 4. The **BATAAN PENINSULA STATE UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
